The selection committee will consider all nominations, ask questions of the nominator as needed, and will do research to determine that the nominee is worthy of consideration. The selection committee chairman will present the selected nominee to the LSS board prior to the LSS Roundup.

LSS would like to award the honor of receiving the Spirit of Christmas Legacy to someone local or regional to where the annual 'round up' is being held; therefore, maximizing the opportunity to make a full and lasting impact on the individual or organization being recognized by Lone Star Santas for their 'from the heart' activities, generosity and 'Spirit of Christmas'.

Process for nomination to the 'list' of candidates:

(Please submit the following by **January 15, 2026** to Santa Bruce Hickman at **tbhickman@sbcglobal.net**)

1. Please provide as much logistical or informational data possible.
  - a. Name of individual, group or organization.
  - b. Address, web site, email and direct phone contact if available.
2. List a full and complete history of individual, group or organization.
3. What they do and have done to put forward the Spirit of Christmas.
4. A general summary included with the nomination form. Please write a brief paragraph or two on why you think this individual, group or organization should be considered for the Spirit of Christmas Legacy award.
5. What community's do they serve or are active in.
6. Indicate if they are a 501 (c) non-profit organization.
7. Indicate how they are funded and if you feel they are financially stable and responsible.
8. Explain how you came to recognize them as a potential candidate.
9. Indicate whether or not you have any specific connection to the candidate, i.e., financial contributor, you are their 'Santa', participated in an event hosted by the nominee, or if you have any type of commitment to the nominee for any reason.
10. Please attach to the nomination form any informational documents, stories, photos, etc., that support your nominee and their actions.
11. Use page three (3/4) to complete and submit your nomination.
